2. INFORMATION ABOUT

3. SCOPE - WHAT DOES THIS POLICY COVER?

- 5.3 With your permission and where permitted by law, We may also use your data for marketing purposes, which may include contacting you by email or telephone or post with information, news and offers on Our products and services. We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that We fully protect your rights and comply with Our obligations under the Data Protection Act 1998 and the Privacy and Electronic Communications (EC Directive) Regulations 2003, as amended in 2004, 2011 and 2015.

6. HOW AND WHERE DO WE STORE YOUR DATA?

- 6.1 We only keep your data for as long as we need to in order to use it as described above in section 5.
- 6.2 Your data will only be stored within the European Economic Area ("the EEA") (The EEA consists of all EU member states, plus Norway, Iceland and Liechtenstein).
- 6.3 Data security is of great importance to us, and to protect your data, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure data collected through Our Site.
- 6.4 Notwithstanding the security measures that We take, it is important to remember that the transmission of data via the internet may not be completely secure and that you are advised to take suitable precautions when transmitting to Us data via the internet.

7. DO WE SHARE YOUR DATA?
